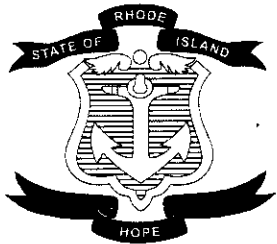
MINUTES OF DECEMBER 1, 2016 MEETING
