





Articles of Dissolution


MINUTES OF JULY 31, 2016 DIRECTOR'S MEETING

4. It is further hereby stipulated that the Shareholder has cast his vote to dissolve and that he is of sound mind, and is operating under no undue influence or duress.


There being no further business to come before the meeting, upon motion duly made, seconded and unanimously carried, it was adjourned this 31st day of July, 2016.


