It is enacted by the General Assembly as follows:

- 1       SECTION 1. The time within which MOSLEM GROTTO MYSTIC ORDER VEILED  
2       PROPHETS OF THE ENCHANTED REALM, incorporated on April 6, 1955, shall file the  
3       reports for the years 1992, 1993, 1994, 1995, 1996, 1997, 1998, 1999, 2000, 2001, 2002, 2003,  
4       2004, 2005, 2006, 2007, 2008, 2009, 2010, 2011, 2012, 2013, 2014, 2015, 2016 and 2017, as  
5       required under the provisions of §7-6-90 of the general laws of Rhode Island, 1956, is hereby  
6       extended to the 31st day of December, A.D., 2017, if said corporation shall file in the office of  
7       the secretary of state before December 31, 2017, the reports which it should have filed in the said  
8       years and shall pay to the secretary of state the filing fees therefor, having previously thereto paid  
9       to the general treasurer for the use of the state such sum as the attorney general shall decide  
10      should be paid by said corporation as a compromise for the penalty or penalties for its failure to  
11      file such reports then the forfeiture or revocation of the charter of said corporation shall  
12      thereupon, to wit, upon the filing of said reports and the payment of said fees, be vacated and said  
13      corporation shall thereupon be entitled to all of the privileges, benefits and powers and subject to  
14      the same duties and liabilities as though no forfeiture or revocation of its said charter had taken  
15      place.  
16      SECTION 2. This act shall take effect upon passage.
