Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Project Fearless Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

PURPOSES WITHIN THE MEANING
OF SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE. BOARD OF
DIRECTORS WILL DISPOSE OF ALL
ASSETS UNDER SECTION 501(C)(3) OF IRS CODE. UPON THE DISSOLUTION OF
THE CORPORATION, THE
BOARD OF DIRECTORS SHALL PAY ALL LIABILITIES AND DISPOSE OF ALL ASSETS
OF THE CORPORATION
EXCLUSIVELY FOR THE PURPOSES OF THE CORPORATION IN SUCH MANNER, OR
SUCH ORGANIZATION OR
ORGANIZATIONS ORGANIZED AND THE TIME QUALIFY AS AN EXEMPT
ORGANIZATION OR ORGANIZATIONS
UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OF 1986 (OR THE
CORRESPONDING
PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW), AS THE
BOARD OF DIRECTORS
SHALL DETERMINE. ANY SUCH ASSETS NOT SO DISPOSED OF SHALL BE
DISPOSED OF BY THE CIRCUIT
COURT OF THE COUNTY WHERE THE PRINCIPAL OFFICE IS LOCATED.
