No manager of the company (including members acting as or deemed to be managers for purposes of R.I.G.L. § 7-16-14) of the company shall be personally liable to the company or its members for monetary damages for breach of the manager's duty as a manager; provided, however, that nothing herein contained shall be construed to eliminate or limit the liability of a manager to the extent provided by applicable law (i) for any breach of the manager's duty of loyalty to the company or its members; (ii) for acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law; (iii) with respect to the liability imposed pursuant to provisions of R.I.G.L. § 7-16-17 (as in effect and as hereafter amended); or (iv) for any transaction from which the manager derived an improper personal benefit (unless a transaction is permitted by R.I.G.L. §7-16-8(b)(4), as in effect and as hereafter amended). If the Rhode Island Limited Liability Company Act (the "Act") is amended after the adoption of these Articles of Organization to authorize company action further eliminating or limiting the personal liability of managers, then the liability of each manager of the company shall be eliminated or limited to the fullest extent permitted by the Act, as so amended. Neither the amendment nor repeal of this Article Sixth nor the adoption of any provision of these Articles of Organization inconsistent with this Article Sixth shall eliminate or reduce the effect of this Article Sixth with respect to any matter occurring, or any cause of action, suit or claim that, but for this Article Sixth would have occurred or arisen, prior to such amendment, repeal or adoption.
