ARTICLE I

The name of the corporation is Windermere Association

ARTICLE II

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE CORPORATION DOES NOT CONTEMPLATE PECUNIARY GAIN OR BENEFIT, DIRECT

OR INDIRECT, TO ITS MEMBERS. IN WAY OF EXPLANATION AND NOT OF LIMITATION, THE PURPOSES FOR WHICH IT IS FORMED ARE:

(A) TO BE AND CONSTITUTE THE ASSOCIATION TO WHICH REFERENCE IS MADE IN THE "DECLARATION OF COVENANTS, CONDITIONS, RESTRICTIONS, CHARGES AND LIENS IMPOSED UPON CLUBHOUSE ESTATES SUBDIVISION IN NARRAGANSETT, RHODE ISLAND," AS MAY NOW EXIST AND AS MIGHT HAVE ALREADY

OR MAY HEREINAFTER BE AMENDED (HEREINAFTER REFERRED TO AS THE "DECLARATION"), ESTABLISHING A PLAN OF DEVELOPMENT AND INITIALLY FILED IN THE LAND EVIDENCE RECORDS OF THE TOWN OF NARRAGANSETT, COUNTY OF WASHINGTON, STATE OF RHODE ISLAND, TO PERFORM ALL OBLIGATIONS AND DUTIES OF THE ASSOCIATION, AND TO EXERCISE ALL RIGHTS AND POWERS OF THE ASSOCIATION, AS SPECIFIED THEREIN, IN THE BY-LAWS, AND AS PROVIDED BY LAW;

- (B) TO PROVIDE AN ENTITY FOR THE FURTHERANCE OF THE INTERESTS OF THE OWNERS OF LOTS IN THE DEVELOPMENT;
- (C) TO CARE FOR, MAINTAIN AND PLOW THE PRIVATE ROADS DESIGNATED AS "WINDERMERE ROAD," "CLUBHOUSE DRIVE" AND "FIELD TERRACE;"
- (D) TO ENFORCE CHARGES, EASEMENTS, RESTRICTIONS, CONDITIONS,
- COVENANTS, AND SERVITUDES EXISTING UPON AND CREATED FOR THE BENEFIT OF SAID WINDERMERE ROAD, CLUBHOUSE DRIVE AND FIELD TERRACE AND TO PAY ALL

EXPENSES INCIDENTAL THEREOF; TO ENFORCE THE DECISIONS AND RULINGS OF THE ASSOCIATION; AND TO PAY ALL EXPENSES IN CONNECTION THEREWITH;

(E) TO APPOINT SUCH COMMITTEES AS MAY BE NECESSARY TO, OR

CONVENIENT IN, THE ASSOCIATION DISCHARGING THE DUTIES ENTRUSTED TO IT;

(F) TO LEVY AN ANNUAL CHARGE UPON THE MEMBERS OF THE ASSOCIATION
AND TO SUE TO COLLECT ANY OF SUCH CHARGES AS ARE NOT PAID. SAID ANNUAL
CHARGE SHALL BE FIXED AT AN EQUAL AMOUNT FOR EACH PLATTED NUMBERED
LOT

AND SHALL BE FIXED AT AN ANNUAL MEETING OF THE ASSOCIATION;
(G) TO EXPEND THE MONIES COLLECTED BY THE ASSOCIATION FROM
ASSESSMENTS OR CHARGES, AND OTHER SUMS RECEIVED BY THE ASSOCIATION,
FOR

THE PAYMENT AND DISCHARGE OF ALL PROPER COSTS, EXPENSES, AND OBLIGATIONS INCURRED BY THE ASSOCIATION IN CARRYING OUT ALL OR ANY OF THE PURPOSES FOR WHICH THE ASSOCIATION IS FORMED; AND (H) TO DO ALL THINGS NECESSARY AND PROPER TO ACCOMPLISH THE FOREGOING PURPOSES.
