An ACT to incorporate certain Persons, by the Name of the Six Principles Baptist Society, in the Town of Newport, in this State.

WHEREAS divers Persons, belonging to the Congregation Act incorpo-WHEREAS givers Perions, belonging to the Me Six affembling for the public Worship of Almighty God with rating the Six the Church of Christ called Baptist or Antipadobaptist, in the Town Baptist Soof Newport, now under the pastoral Care of the Reverend Gardner ciety in New-Thurston, professing to believe that Water Baptism ought to be admi- port. nistered by Immersion only, and that professed Believers in Jesus Christ, and no others, are proper Subjects of the same, have petitioned this Assembly to grant them a Charter of Incorporation, with the Privileges and Powers herein after mentioned: Now therefore be it known, That We, the Governor and Company of the State of Rhode-Island and Providence-Plantations, in General Assembly convened, Do, for ourselves and our Successors, Enact, Grant, Ordain, Constitute and Declare, and it is hereby Enacted, Granted, Constituted and Declared, that the Reverend Gardner Thurston, Samuel Fowler, Peleg Barker, Stephen Peckham, Jethro Briggs, Caleb Gardner, Peleg Clarke, Constant Taber, William Burroughs, Nicholas Paris Tillingbist, Philip Moss, Thomas Eyres, Simeon Martin, William Langley, William Taggart, Parker Hall, John M'Quarter, Peleg Barker, jun. Daniel Rogers, John Shaw, John Shearman, Ebenezer Shearman, Clarke Brown, Epbraim Macomber, Joshua Peckbam, William Prior, Daniel Gardner, John Gardner, Joseph Rogers, Elisha Barker, Isaac Barker, Oliver Durfee, John Clarke, Elisha Gibbs, Elisha Lawton, and Gardner Fowler, or such or so many of them as shall convene at the Baptist Meeting in Newport, on the First Monday in June next, on the Business of this Charter, and their Successors, shall be forever hereafter one Body, Corporate and Politic, in Fact and Name, with perpetual Succession, to be known in the Law by the Name of the Six Principles Baptist Society, according to Hebrews, Chap. vi. Ver. 1st and 2d, in the Town of Newport, and State aforesaid. And the said Six Principles Baptist Society is hereby empowered to take, receive and hold, all and any voluntary Subscriptions, Contributions, Legacies and Donations, of

any Sum or Sums of Money, or of any real and personal Effate: Also to have, take, possess, purchase, acquire, or otherwise receive and hold, Lands, Tenements, Hereditaments, Goe'ls, Chattels, or other and many stands of the control of the noig, Langs, Legentents, half and may stand ferzed, norwithstanding any Milnomer of this Corporation, and by whatever Name, or how. ever imperfectly the same shall be described, in Donations, Legacier, Affiguments and Grants, provided the true Intent and Meaning of the Affiguee or Benefactor be evident: Also the said Six Principles Baptist Society is hereby empowered to take, hold, and stand seized of, all Estates aforesaid, solely to and for the Use and Benefit of the faid Baptist or Antipadobaptist Church and Congregation, and their Successors forever; and the same to use, occupy and improve, towards the Support of Pastors, Relief of the Poor in schooling their Children, or otherwise, or any other religious Uses in said Church and Congregation, according to the Will of the Donors, and to the Purposes, Trusts and Uses, to which they shall be seized thereof, or the same shall be designed: Also to leafe the real Estate, or the same to grant, demise, aliene, or hold in Perpetuity, according to the Tenor of each particular Donation, or their Property therein, and to let Monies on Bonds, Mortgages, or other Securities; and shall and may be Persons capable in the Law, as a Body Corporate, to sue and be fued, to plead and be impleaded, to answer and be answered unto, to defend and pursue unto final Judgment and Execution thereon, in all Courts and Places, and before all proper Judges whatever, in all and fingular Suit and Suits, Caufes and Actions, of what Kind feever, in the fullest and amplest Manner, by and in the Name of their Treasurer for the Time being. And furthermore, the faid Body Corporate, and their Successors forever hereafter, shall and may have a public Seal, which they may use for any Purposes or Affairs as to them shall seem expedient: Also, it shall be lawful for them the Seal to break, alter and make anew, from Time to Time, at their Will and Pleafure.

AND be it further Enacted, That there shall be an annual Meeting of the said Six Principles Baptist Society, in the said Town of Newport, on the First Monday in June sorever; at which Time they shall, out of their own Body Politic, elect a Moderator, Treasurer and Clerk, and such other Officers as they shall think needful; and that the Moderator, Treasurer and Clerk, be sworn to the saithful Personnance of their respective Trusts.

And furthermore, there shall be a Quarterly-Meeting of said Six Principles Baptist Society on the First Mondays in September, December and March, sorever: That the said Six Principles Baptist Society shall have sull Power to appoint any other Meetings, at such Times and Places as to them from Time to Time shall seem necessary or expedient, more sully and effectually to accomplish the charitable Purposes aforesaid: And that they have Power at any such Meetings so appoint Committees, and transact all such Business as according to this Charter may regularly come before them; all which shall be done and determined by a Majority of the Members present.

AND be it further Enacted, That whatever Monies or other Eftates, both real and personal, the said Six Principles Baptist Society may become seized or possessed of, shall be and remain a capital Stock of Fund, and only the Interest, yearly Prosits or Income thereof, shall be applied and appropriated to the Use of the said Baptist or Antipadobaptist Church and Congregation.

AND be it further Enatted, That Samuel Fowler be the First Moderator, Peleg Clarke the First Treasurer, and Peleg Barker, jun. the First Clerk of the said Six Principles Baptist Society, to continue in their respective Offices until the First Monday in June, One Thousand Seven Hundred and Eighty-sour.

AND be it further Enacted, That the said Six Principles Baptist Society, at any of their Meetings, may elect such Persons as they shall think proper to become Members of the same, and make such Rules, Orders and By-Laws, and alter the same, as they from Time to Time shall judge necessary for the good Order of said Society: Provided that such Rules, Orders and By-Laws, are not contrary to the Laws of this State; and that any Seven Members of the said Six Principles Baptist Society, convened at any regular Meeting (the Moderator, Treasurer, or Clerk, always to be one) are hereby declared to be a Quorum of the said Society.

AND be it further Enalled, That all Donations, of whatsoever Kind, or howsoever made, to the said Six Principles Baptist Society, together with the Names of the Donors, and the Purposes and Uses for which said Donations shall be made, shall be entered on Record by the Clerk for the Time being; as also their yearly Income, and its Appropriation, from Time to Time forever; and that the Treasurer's Accounts be exhibited and audited at every annual Meeting of the said Society.

PROVIDED nevertheless, and be it further Enacted, That if ever the whole Number of the said Six Principles Baptist Society, for the Time being, shall be reduced below Seven, then, and in such Case, all Monies, Bonds, Mortgages, Deeds, Notes, Obligations, Books and Papers of every Kind, together with all the Estate, both real and personal, at that Time belonging to the said Six Principles Baptist Society, shall be given up to, and the sole Property thereof be vested in, the sty, shall be given up to, and the sole Property thereof be vested in, the Baptist or Antipedobaptist Church and Congregation asoresaid, for whose Use and Benefit the said Six Principles Baptist Society is instituted, to be received by a Committee by them appointed for that Purpose; and shall be punctually appropriated by them to the Purposes, Trusts and Uses, specified by the Donors to the said Six Principles Baptist Society, or to which they are by this Charter empowered to appropriate the same, and no otherwise.

PROVIDED furthermore, and it is furthermore Enacted, That no Part of this Charter shall be construed or understood to grant any Power or Powers to the said Six Principles Baptist Society to raise any H

Sum or Sums of Money any otherwise than by free and voluntary Subscription, Contribution, Legacy or Donation. And in case, at any Time hereafter, through Misapprehension or mistaken Construction of the Powers contained in this Charter, any Laws shall be enacted, or any Matters done and transacted by this Corporation, contrary to the Tenor hereof, such Laws, Acts and Doings, shall be in themselves null and void; but shall never be adjudged into an Avoidance, Deseazance or Forseiture, of this Charter; but the same shall remain entire to the said Corporation in perpetual Succession forever, and all their Acts conformable to its Powers, Tenor, true Intent and Meaning, shall be and remain in full Force and legal Validity.
