

"Said district may also include such other fire or lighting districts situated in the town of Coventry which may from time to time request to be included in the Coventry fire district. Said request shall be accompanied by a certified copy of the vote taken at any annual and special meeting showing that a majority of the taxable inhabitants present and voting at any annual or special meeting have expressed a desire to be included within the Coventry fire district.

"Upon receipt of the request as heretofore stated the taxable inhabitants of the Coventry fire district may at any annual or special meeting, by a majority vote of said taxable inhabitants present and voting at any such meeting accept or reject such request. If such request is approved the said taxable inhabitants of such fire or lighting districts shall be entitled to all the rights and privileges and be subject to all the duties and obligations of taxable inhabitants of the Coventry fire district."

SEC. 2. This act shall take effect upon its passage and all acts and parts of acts inconsistent herewith are hereby repealed.
