Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is MIRAD QUE NADIE OS ENGAÑE, INC.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

2. IN CASE OF DISSOLUTION, ANY ASSETS WILL BE DISTRIBUTED TO IGLESIA DE DIOS ELOHIM, INC.
3. THE PURPOSE OF THIS ORGANIZATION IS TO TEACH, AND PREACH THE BIBLE THROUGH INTERNET OR IN PERSON. THE ORGANIZATION WILL DISTRIBUTE FREE CHRISTIAN LITERATURE IN PERSON OR THROUGH THE INTERNET, AND MAY PROVIDE CHRISTIAN PASTORAL COUNSELING.
