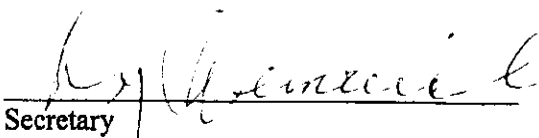

**VOTED:** The Articles of Dissolution will be prepared and filed by corporate counsel, Votta & Votta Law Offices, Ltd.

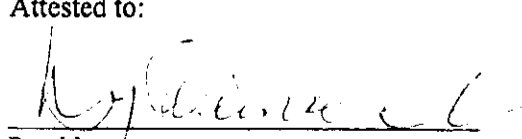


