withdrawn and their articles of incorporation to transact business in the State of Rhode

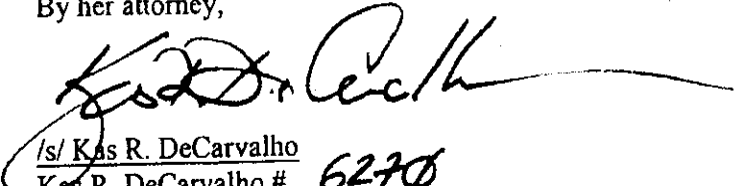
