The specific purpose or purposes for which the corporation is organized are:

GREEN CASTLE IS A THERAPEUTIC, CHARITABLE AND EDUCATIONAL ORGANIZATION THAT WILL PROVIDE AGRICULTURAL PROGRAMS TO TARGETED POPULATIONS SUCH AS SCHOOL CHILDREN, SENIORS AND RETURNING COMBAT VETERANS.
