**Business Corporation  
Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Greenville Bakery, Inc.

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

**ARTICLE II**

The corporation has the purpose of engaging in any lawful business, and shall have perpetual existence until dissolved or terminated in accordance with Chapter 7-1.2.

**ARTICLE V**

Additional provisions, if any, not inconsistent with Chapter 7-1.2 which the incorporators elect to have set forth in these Articles of Incorporation:

ANY STOCKHOLDER, INCLUDING THE HEIRS, ASSIGNS, EXECUTORS OR ADMINISTRATORS OF A DECEASED STOCKHOLDER, DESIRING TO SELL OR TRANSFER

SUCH STOCK OWNED BY HIM OR HER, WILL FIRST OFFER SAME TO THE CORPORATION AT THE LOWEST PRICE HE OR SHE IS WILLING TO SELL SAME. SAID OFFER IS TO BE IN WRITING AND WILL CONTAIN A STATEMENT WITH THE NAMES AND ADDRESSES OF THE TRANSFEREES TO WHOM THE STOCKHOLDER INTENDS TO SELL OR TRANSFER THEIR STOCK IN THE EVENT THAT THE OFFER IS NOT ACCEPTED BY THE CORPORATION.

SAID OFFER AND STATEMENT WILL BE ADDRESSED TO THE BOARD OF THE CORPORATION AT THE PRINCIPAL PLACE OF BUSINESS. THE CORPORATION WILL HAVE TWENTY (20) DAYS AFTER THE DELIVERY OF SAID OFFER AND STATEMENT TO ACCEPT OR REJECT SAID OFFER AND UNTIL ACTION THEREON IS TAKEN, OR UNTIL THE EXPIRATION OF SAID TWENTY (20) DAYS, WHICHEVER OCCURS FIRST, NO TRANSFER OF SUCH STOCK WILL BE MADE BY THE STOCKHOLDER SUBMITTING SAID OFFER AND STATEMENT.

IN THE EVENT THAT THE CORPORATION REJECTS SAID OFFER OR DOES NOT TAKE ANY ACTION WITHIN SAID TWENTY (20) DAYS, THE STOCKHOLDER MAY THEN SELL OR TRANSFER SAID STOCK AT NOT LESS THAN THE PRICE FIXED IN SAID OFFER TO THE TRANSFEREES LISTED IN SAID STATEMENT AT ANY TIME WITHIN THREE (3) MONTHS AFTER THE EXPIRATION OF SAID TWENTY (20) DAYS, BUT NOT OTHERWISE OR THEREAFTER WITHOUT AGAIN COMPLYING WITH THE PROVISIONS HEREIN.

TRANSFERS BY WAY OF PLEDGE, ATTACHMENT OR OTHER ENCUMBRANCES ARE INCLUDED IN THE PROHIBITIONS OF THE PROVISIONS HEREIN.

ANY TRANSFER CONTRARY TO THE FOREGOING PROVISIONS IS VOID UNLESS THE CORPORATION BY RESOLUTION OF ITS STOCKHOLDERS WAIVES THE FOREGOING PROVISIONS WITH RESPECT TO ANY PARTICULAR TRANSFER.
