These final corporate minutes are recorded on October 17, 2107.

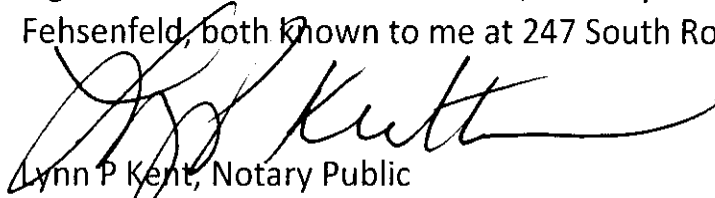
