







Witnesseth, that Seller, in consideration of the sum of [REDACTED] Dollars and other good and valuable consideration paid to Seller by Buyer, receipt and sufficiency of which is hereby acknowledged, delivers, grants, bargains, sells and transfers forever to Buyer the following goods and chattels, to wit:

In addition to those goods and chattels listed on Exhibit A, the Seller hereby grants to Buyer:

1.1 The Exclusive and entirety of all right, title and interest to the customer lists of said Seller, including customer names, addresses, phone numbers and contact representatives, as well as, all information relating to any products owned or purchased by Seller's customers and Seller's sales prospects, and also including any computer software and hardware relating to all Seller customers.

1.2 All other files, documents, papers, computer software and hardware, and computer records relating to the Seller's Customer List.

1.3 The exclusive and perpetual use of the name "Olga's Cup & Saucer" as well as any substantially similar name thereto as well as such names as are reasonably likely to lead to confusion or mis-identification. The terms of this entire document, including but not limited to this paragraph 1.3 shall survive the transaction's closing.

1.4 Seller shall cooperate with Buyer in transferring Seller's telephone number, to wit, [REDACTED] Buyer shall bear all costs associated with said transfer.

1.5 The exclusive commercial use of all recipes, formulas, and proprietary knowledge of and related to Seller's goods and products.

Seller covenants to Buyer that Seller is the lawful owner of the said goods and chattels; that they are free from all encumbrances; that Seller has good right to sell that property, and that Seller will warrant and defend the sale of said property, goods and chattels unto the Buyer against the lawful claims and demands of all persons whomsoever. This paragraph shall survive the closing.

"Seller" and "Buyer" shall be used for singular or plural, natural or artificial, which terms shall include the heirs, legal representatives, successors and assigns to Seller and Buyer wherever the context so requires or admits.
