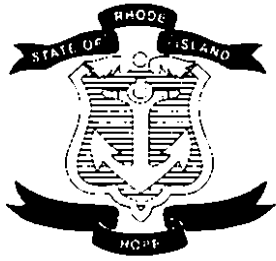
PLAN OF LIQUIDATION
