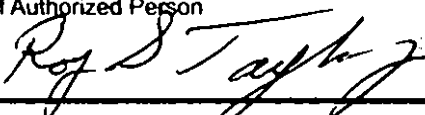

Notice of Intent to Dissolve the Partnership

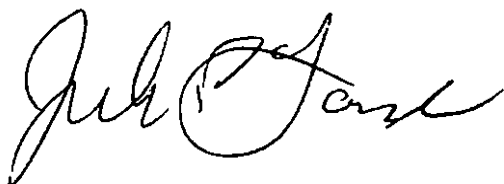
To the Secretary of State of the State of Rhode Island:

Pursuant to Section 7-1.2-1303 of the Rhode Island General Laws, the undersigned partnership submits the following notice of intent to dissolve the partnership:

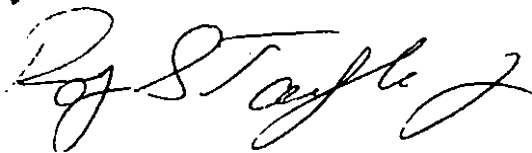
1. The name of the partnership is: JR, LLC
2. On December 15, 2017 the partners of the partnership unanimously adopted a resolution to begin dissolution of the corporation on December 15, 2017. The resolution further sets forth the following:
 - A. That at the earliest practicable date, the following will be accomplished:
 - (1) Complete liquidation of JR, LLC,
 - (2) Payment of all corporate debts, and
 - (3) Distribution of any remaining cash, securities, and cash realized from the sale of securities or partnership assets to the partners.
 - B. That the partners of JR, LLC are authorized and directed to immediately initiate the liquidation of the partnership so that its assets or the proceeds therefrom can be distributed to its partners prior to December 15, 2017.
 - C. That promptly thereafter, the charter and franchise of JR, LLC will be surrendered and the partnership dissolved.
 - D. That JR, LLC discontinue transacting all business as of December 15, 2017, except that which is necessary or incidental to liquidation and winding up affairs.
