- A. To buy, sell, trade, trade in, deal in and deal with all personal property of all kinds, including manufacturing products, supplies, products, property and merchandise manufactured, produced, purchased, sold and traded by retail and wholesale manufacturing products producers, manufacturers, agents, stores, outlets, natural and otherwise and property and merchandise of every kind and nature, and to buy, sell, trade, trade in, deal in and deal with any and all articles and property of every kind and nature as may be necessary or incidental to such business.
- B. To buy, sell, hold, acquire, mortgage, lease and convey any and all real and personal property of any kind, nature and description, so far as is necessary in conducting the business of the corporation and; to purchase or otherwise dispose of the shares of the capital stock or any bonds, obligations, or other securities or evidences of indebtedness, goodwill, rights, franchises, assets, and property of every and any kind, or any part thereof, of other corporations, domestic or foreign, and, if desirable, to issue in exchange therefor the stock, bonds or other obligations of this company; to assume the liabilities of other corporations, and to operate their properties, either in the name of the company or of any other corporation.
- C. To act as the agent or representative of any business, corporation, firm or individual.
- D. To make and enter into any contract, agreement and obligation by, between and with any person, natural or otherwise, so far as is necessary, convenient or expedient in conducting the business of the corporation.
- E. To do business under any trade name which the corporation deems necessary, convenient or expedient.
- F. To carry on any activity permitted by the laws of the State of Rhode Island as amended and as hereafter amended.
- G. In the event that a stockholder (the selling stockholder) desires to sell all or a portion of his/her stock and receives a bona fide offer from a third party for the purchase of the same which the stockholder desires to accept, he/she shall first offer said shares to the other stockholder(s) (the remaining stockholder(s)) for the purchase of his/her stock on the same terms and conditions.
- H. Said offer shall be made in writing and it shall recite the number of share(s) to be sold, the address of the proposed purchaser, the purchase price, and any other terms of sale.
- I. The remaining stockholders shall then have the right to purchase said shares on the same terms and conditions as are stated in the aforesaid offer by giving written notice to the selling stockholder of the intention to purchase the stock within fifteen days of the selling stockholder's written offer.
- J. If the remaining stockholder exercises his/her right to purchase said shares the transaction shall be closed no later than thirty (30) days following the remaining stockholders exercise of his/her option to purchase. If the remaining stockholder fails to exercise his/her option to purchase or, having exercised it, fails to complete the purchase as required, said shares may be sold by the selling stockholder to a third party in accordance with said offer, but on no other terms and conditions without again complying with this provision.
