Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Providence Patriots Youth Football and Cheerleading

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THIS ORGANIZATION IS ORGANIZED TO PROVIDE HEALTHY AND SAFE ENVIRONMENT

FOR YOUNG PEOPLE AGES 5 THROUGH 18, INCLUSIVE, TO LEARN FOOTBALL AND CHEERLEADING, DANCE, AND THE PRINCIPLES OF GOOD SPORTSMANSHIP IRRESPECTIVE OF RACE, GENDER, NATIONALITY, RELIGIOUS BELIEFS, ATHLETIC ABILITY, OR ABILITY TO PAY REGISTRATION FEES.

THIS ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES UNDER SECTION 501(3)(C) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

UPON DISSOLUTION OF THIS ORGANIZATION, ASSETS SHALL BE DISTRIBUTED FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(3)(C) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE TAX

CODE, SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR PUBLIC PURPOSE.
