## BILL OF SALE

This Bill of Sale shall be governed by and construed in accordance with the laws of the State of Rhode Island, without regard to principles of conflicts of law.

The provisions of this Bill of Sale may not be amended, modified or waived except by the written agreement of each of Seller and Buyer.
