Pursuant to the provisions of Section 7-6-40 of the General Laws of Rhode Island, 1956, as amended, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the corporation is Mindy Independent

2. The following amendment to the Articles of Incorporation was adopted by the corporation:

Article III: Amend to "to provide a quality education for students"

Article IV: Add "Mindy Independent is organized exclusively for charitable, religious, educational, and scientific purposes including, for such purposes, the making of distributions to organizations as exempt organizations described under Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a or to a state or local government for public purpose. Any such assets not disposed of

by a court of competent jurisdiction in the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or

organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
