Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Friends of Galilee

ARTICLE II

The period of its duration is Perpetual _____

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THIS CORPORATION, FRIENDS OF GALILEE IS ORGANIZED EXCLUSIVELY FOR SUPPORTING, MAINTAINING, FURTHERING AND PRESERVING THE HISTORIC FISHING VILLAGE OF GALILEE, RHODE ISLAND WHILE STIMULATING THE FUTURE PLANNING AND DEVELOPMENT IN GALILEE, RHODE ISLAND. FRIENDS OF GALILEE SEEK TO ACCOMPLISH THIS MISSION WITH THE FOLLOWING CORE VALUES: (1) INTEGRITY; (2) COMMUNITY ENGAGEMENT; (3) PERSEVERANCE; AND (4) NOSTALGIA. THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR ONE OR MORE PURPOSES AS SPECIFIED IN SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, INCLUDING, FOR SUCH PURPOSES, AS SOLICITING AND RECEIVING GIFTS AND GRANTS OF MONEY AND PROPERTY, AND TO DO ANYTHING NECESSARY OR PROPER FOR ACCOMPLISHMENT OF THESE PURPOSES NOT OTHERWISE INCONSISTENT WITH SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE. ALL FUNDS, WHETHER INCOME OR PRINCIPAL, AND WHETHER ACQUIRED BY GIFT OR CONTRIBUTION OR OTHERWISE, SHALL BE DEVOTED TO SAID PURPOSES.

1. NO PART OF THE NET EARNINGS OF THE CORPORATION SHALL INURE TO THE BENEFIT OF, OR BE DISTRIBUTABLE TO, ITS MEMBERS, DIRECTORS, OR TRUSTEES, OFFICERS, OR OTHER PRIVATE PERSONS, EXCEPT THAT THE CORPORATION SHALL BE AUTHORIZED AND EMPOWERED TO PAY REASONABLE COMPENSATION FOR SERVICES RENDERED AND TO MAKE PAYMENTS AND DISTRIBUTIONS IN FURTHERANCE OF THE PURPOSES OF THIS CORPORATION. NO SUBSTANTIAL PART OF THE ACTIVITIES OF THIS CORPORATION SHALL BE THE CARRYING ON OF PROPAGANDA, OR OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION (EXCEPT AS OTHERWISE PROVIDED BY SECTION 501(H) OF THE INTERNAL REVENUE CODE), AND THIS CORPORATION SHALL NOT PARTICIPATE IN, OR INTERVENE IN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF STATEMENTS), ANY POLITICAL CAMPAIGN ON BEHALF OF, OR IN OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE. NOTWITHSTANDING ANY OTHER PROVISIONS OF THESE BYLAWS, THIS CORPORATION SHALL NOT CARRY ON ANY ACTIVITIES NOT PERMITTED TO BE CARRIED ON (A) BY A CORPORATION EXEMPT FROM FEDERAL

INCOME TAX UNDER SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR (B) BY A CORPORATION , CONTRIBUTIONS TO WHICH ARE DEDUCTABLE UNDER SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE.

2. UPON DISSOLUTION OF THE CORPORATION, ITS ASSETS REMAINING SHALL BE DISTRIBUTED BY THE BOARD OF DIRECTORS, AFTER PAYING OR MAKING PROVISIONS FOR THE PAYMENT OF ALL DEBTS, OBLIGATIONS, LIABILITIES, COSTS AND EXPENSES OF THE CORPORATION, FOR ONE OR MORE EXEMPT PURPOSES WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE, OR SHALL BE DISTRIBUTED TO THE FEDERAL GOVERNMENT, OR TO A STATE OR LOCAL GOVERNMENT, FOR A PUBLIC PURPOSE. SUCH DISTRIBUTION SHALL BE MADE IN ACCORDANCE WITH ALL APPLICABLE PROVISIONS OF THE LAWS OF THIS STATE.
