Articles of Incorporation**

(Chapter 7-1.2- of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is R & S AUTOMOTIVE INC

This is a close corporation pursuant to § 7-1.2-1701 of the General Laws, 1956, as amended. (Uncheck if inapplicable.)

**ARTICLE II**

SUCH ACTIVITIES MAY BE DONE DIRECTLY OR THROUGH OTHER ORGANIZATIONS, ENTITIES, INDIVIDUALS, INDEPENDENT CONTRACTORS AND AGENTS.

TO PURCHASE, LEASE, HIRE, BROKER OR OTHERWISE ACQUIRE OR LEASE REAL OR PERSONAL PROPERTY AND TO SELL, DISPOSE OF LEASE, CONVEY, ENCUMBER AND MORTGAGE SAID PROPERTY OR ANY PART THEREOF. TO BORROW MONEY AND TO MAKE, ENTER INTO, PERFORM AND CARRY OUT CONTRACTS AND AGREEMENTS AND DO EVERYTHING NECESSARY AND PROPER FOR THE ACCOMPLISHMENT OF ANY PURPOSE SO FAR AS AND TO THE EXTENT THAT SAME MAY BE DONE AND PERFORMED BY CORPORATIONS ORGANIZED UNDER RHODE ISLAND PROVISIONS OF CHAPTER 7-1.2 OF THE GENERAL LAWS, 1956, AS AMENDED . MAY ACT AS A PARTNER, OWN OR OPERATE MULTIPLE BUSINESSES, AND MAY ELECT TO BE TREATED AS A S-CORPORATION FOR TAX PURPOSES.
