ARTICLES OF INCORPORATION

OF

The EWGA Rhode Island Chapter of the Executive Women's Golf Association

IN ADDITION TO THE PROVISIONS REQUIRED BY THE CORPORATE LAWS WITHIN THE STATE THAT THE CHAPTER WILL BE INCORPORATING, EWGA REQUIRES THE FOLLOWING LANGUAGE BE CONTAINED IN ANY CHAPTERS ARTICLES OF INCORPORATION

#### ARTICLE 1

NAME: EWGA Rhode Island Chapter of the Executive Women's Golf Association

#### ARTICLE 2

<u>PURPOSES</u>: This Corporation is organized and shall be administered and operated exclusively to receive, administer, and expend funds for the following purposes:

To provide leadership and other educational programs, golf instruction and networking activities to women to improve their leadership abilities, self-esteem and business skills through golf.

## **ARTICLE 3**

<u>MEMBERSHIP</u>: The Corporation shall have voting members as set forth in the bylaws.

#### **ARTICLE 4**

<u>PRIVATE INUREMENT</u>: No part of the net income of the corporation shall inure to the benefit of or be distributable to its directors, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services actually rendered and to make payments and distributions in furtherance of the purposes and objects set forth in Article THIRD hereof.

#### ARTICLE 5

TAX RESTRICITIONS: Notwithstanding any other provision of these Articles, the corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt under Section 501(c)(6) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.

#### ARTICLE 6

<u>DISSOLUTION</u>: Upon the dissolution of the corporation, the winding up of its affairs, or the termination of the termination of the affiliation agreement with the Executive Women's Golf Association, the assets of the corporation shall be distributed exclusively for the common business interests of its members or to organizations which are exempt from Federal tax under §501(c) (3) or §501(c) (6) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent federal tax laws.
