Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Savvy Giving by Design Rhode Island, Inc.

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO PROVIDE COMFORT, SUPPORT, AND HEALING TO FAMILIES WITH A CHILD
FACING A MEDICAL CRISIS BY TRANSFORMING
THE INTERIOR SPACES OF THEIR HOMES AT NO COST TO THEM.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

(A) THIS CORPORATION IS ORGANIZED AND OPERATED EXCLUSIVELY FOR
CHARITABLE AND EDUCATIONAL PURPOSES
WITHIN THE MEANING OF SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE.

(B) NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THE
CORPORATION SHALL NOT CARRY ON ANY OTHER
ACTIVITIES NOT PERMITTED TO BE CARRIED ON (1) BY A CORPORATION EXEMPT
FROM FEDERAL INCOME TAX UNDER
SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE OR (2) BY A CORPORATION
CONTRIBUTIONS TO WHICH ARE
DEDUCTIBLE UNDER SECTION 170(C)(2) OF THE INTERNAL REVENUE CODE.

(C) NO SUBSTANTIAL PART OF THE ACTIVITIES OF THIS CORPORATION SHALL
CONSIST OF CARRYING ON PROPAGANDA, OR
OTHERWISE ATTEMPTING TO INFLUENCE LEGISLATION, AND THE CORPORATION
SHALL NOT PARTICIPATE OR INTERVENE IN
ANY POLITICAL CAMPAIGN (INCLUDING THE PUBLISHING OR DISTRIBUTION OF
STATEMENTS) ON BEHALF OF, OR IN
OPPOSITION TO, ANY CANDIDATE FOR PUBLIC OFFICE.
