Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Black Spade Farm

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO MAINTAIN AS OPEN SPACE AND IMPROVE THE HEALTH OF THE FOREST AND INDIGENOUS ANIMAL POPULATION THAT RESIDES ON THE ACREAGE ASSOCIATED WITH THE ORGANIZATIONS CONSERVATION ACTIVITIES. TO SUPPORT THE APPROPRIATE HARVESTING, USE AND RECYCLING OF FORESTRY PRODUCTS TO PROMOTE FOREST HEALTH. TO SUPPORT ALTERNATE FORMS OF VIABLE GREEN ENERGY GENERATING TECHNOLOGIES.
