The following additional provisions are added to the Articles of Incorporation:

- 8.1. The corporation shall have seven directors. The holder of Class A shares shall be entitled to designate four directors. The holders of Class B shares shall elect three directors following procedures to be stated in the corporation's bylaws.
- 8.2. All classes of shares shall have the same rights to dividends, and the same rights upon dissolution, and to any other economic benefits of share ownership.
