"VOTED, That

The name of The Methodist Episcopal Church of
Portsmouth be changed to the Community Methodist Church

It is acknowledged that since 1871, the date of
incorporation by the General Assembly, the Methodist
Episcopal Church of Portsmouth has also been known as the
"Methodist Church", "St. Paul's Methodist Church", and
"Methodist Episcopal Church", also as "Community Methodist
Church of Portsmouth", "Saint Paul's Methodist Church of
Portsmouth" and "Saint Paul's Methodist Episcopal Church
of Portsmouth"

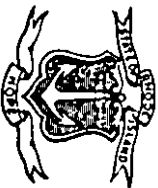
