Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Science and Engineering Fair

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSE OF THE RHODE ISLAND SCIENCE AND ENGINEERING FAIR SHALL BE TO PROMOTE EXCELLENCE IN SCIENCE, AND ENGINEERING EDUCATION. TO THIS END, THE RHODE ISLAND SCIENCE AND ENGINEERING FAIR WILL CONDUCT AN ANNUAL SCIENCE, AND ENGINEERING FAIR IN ADHERENCE TO THE RULES AND REGULATIONS OF THE INTERNATIONAL SCIENCE AND ENGINEERING FAIR (ISEF).
