Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is SHEMA ISRAEL COMMUNITIES RHODE ISLAND INC

ARTICLE II

The period of its duration is X Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

IT IS ESTABLISHED IN THE CITY OF JOHNSTON, RHODE ISLAND STATE, SHEMA ISRAEL COMMUNITIES ROHDE ISLAND, AS A NON-PROFIT RELIGIOUS ORGANIZATION, , AN INTEGRAL PART OF A NETWORK OF JEWISH COMMUNITIES, OF MESSIANIC SYNAGOGUES CONVICTION, WHICH WILL BE GOVERNED BY SHEMA ISRAEL COMMUNITIES STATUTE PREVIOUSLY ESTABLISHED IN THE CITY OF MIAMI, IN THE STATE OF FLORIDA. SHEMA ISRAEL COMMUNITIES ROHDE ISLAND, WILL HAVE ITS OWN GENERAL ASSEMBLY, LOCAL DIRECTIVE, SECRETARIES AND TREASURERS, IN ADDITION OF THE A COUNCIL OF ELDERS, AND TO DISCUSS ITS OWN LOCAL ISSUES AND ACHIEVEMENTS AND RESPOND TO THE COMMITMENTS IT TAKES TO ASSUME AS A LOCAL COMMUNITY.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

- I. AS LONG AS A COUNCIL OF ELDERS HAS NOT BEEN ESTABLISHED, THE PRESIDENT SHALL APPOINT, IN ACCORDANCE WITH THE GENERAL ASSEMBLY OF FOUNDING MEMBERS, A TEMPORARY COMMITTEE FORMED BY FIVE OF THE ASSEMBLY.
- II. SHEMA ISRAEL COMMUNITIES RHODE ISLAND, INC. WILL BENEFIT FROM THE ACQUIRED TAX EXEMPT RIGHTS, THROUGH DULY AUTHORIZED DOCUMENTATION, OF THE SHEMA ISRAEL COMMUNITIES, INC. AGREEMENTS ESTABLISHED IN MIAMI, STATE OF FLORIDA.
- III. RESOLVED THAT ANY SALARIES, WAGES, TOGETHER FRINGE BENEFITS OR FORMS COMPENSATION (HOUSING, TRANSPORTATION AND OTHER ALLOWANCES) PAID TO OR PROVIDED OUR EMPLOYEES, DIRECTORS, OR OFFICERS WILL NOT EXCEED A VALUE WHICH IS REASONABLE AND COMMENSURATE WITH THE DUTIES AND WORKING HOURS ASSOCIATED WITH SUCH EMPLOYMENT AND WITH THE COMPENSATION ORDINARILY PAID PERSONS WITH SIMILAR POSITIONS OR DUTIES.

IV. THIS CORPORATION IS ORGANIZED EXCLUSIVELY FOR ONE OR MORE PURPOSES SPECIFIED IN SECTION 501 (C)(3) OF THE INTERNAL REVENUE CODE, INCLUDING FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS THAT QUALIFY AS EXEMPT ORGANIZATIONS UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

V. NOTWITHSTANDING ANY OTHER PROVISION OF THESE ARTICLES, THIS CORPORATION SHALL NOT CARRY ON ANY OTHER ACTIVITIES NOT PERMITTED TO BE CARRIED ON (1) BY A CORPORATION EXEMPT FROM FEDERAL INCOME TAX UNDER SECTION 501 (C)(3) OF THE INTERNAL REVENUE CODE OR (2) BY CORPORATION CONTRIBUTIONS TO WHICH ARE DEDUCTIBLE UNDER SECTION 170 (C) (2) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED STATES INTERNAL REVENUE LAW.

VI. IN THE EVENT OF DISSOLUTION OF THIS CORPORATION, ITS ASSETS REMAINING AFTER PAYMENT, OR PROVISION FOR PAYMENT, OF ALL DEBTS AND LIABILITIES OF THIS CORPORATION SHALL BE DISTRIBUTED AND TURNED OVER TO ONE OR MORE ORGANIZATIONS WHICH THEMSELVES ARE EXEMPT AS ORGANIZATIONS DESCRIBED IN SECTION 501 (C) (3) AND 170 (C) (2) OF THE INTERNAL REVENUE CODE OF 1986 OR THE CORRESPONDING SECTIONS OF ANY PRIOR OR FUTURE INTERNAL REVENUE CODE, OR TO THE FEDERAL STATE, OR LOCAL GOVERNMENT FOR EXCLUSIVE PUBLIC PURPOSE. THE CORPORATION WILL EXIST TO PERPETUITY UNLESS IT IS DISSOLVED BY THE LAW OR AS ANTICIPATED BY THE STATUTE OF FLORIDA 617.05. (OR OTHER STATUTES REGARDING SUCH DISSOLUTION), AND BY MAJORITY, RESULTING DECISION OF THREE ORDINARY SECTIONS. IN CASE OF DISSOLUTION OF THIS CORPORATION: THE MOATSET HA'ZKENIM (COUNCIL OF ELDERS) WILL BE IN CHARGE OF THAT DISTRIBUTION.

VII. TO THE DISSOLUTION OF THIS CORPORATION, NO PART OF ITS GOODS MUST RESULT TO THE BENEFIT OF SOME INDIVIDUAL OR PRIVATE ORGANIZATION, INCLUDING A MEMBER OF THE COMMUNITY, EXCEPT BEING COMPENSATION BY DEBTS BY SERVICE.

VIII. SHEMA ISRAEL COMMUNITIES RHODE ISLAND, INC., WILL HAVE BANKING ACCOUNTS WITH WHICH WILL ADMINISTER THE CONTRIBUTIONS AND DONATIONS, MAASERIM (TITHES), TRUMOT (OFFERINGS), RESHITIOT (FIRST FRUITS) RECEIVED FROM THE MEMBERS AND SUPPORTERS OF ITS CAUSE.

A. THESE BANKING ACCOUNTS WILL HAVE THE SIGNS OF FOUR MEMBERS OF THE DIRECTORY, AND THE CHECKS TWO OF THOSE FOUR. .

B. THE FINANCIAL RECORDS IN CONFORMITY OF THE INTERNAL PROCEDURES WITH THE SUPERVISION OF THE RABBI AND PRESIDENT.

IX. THE AMENDMENTS OF THESE ARTICLES WILL BE RECOGNIZED AFTER BEING PUT UNDER THE OPINION OF THE MOATSET HA'ZKENIM (COUNCIL OF ELDERS), GUF HA'SHAMASHIM (BODY OF DEACONS), AND THE OPINION OF THE MEMBERS IN EXTRAORDINARY GENERAL ASSEMBLY, SUMMONED FOR SPECIFIC AIM, AND THEN WILL BE PUT UNDER THE RESPECTIVE ORGAN OF THE STATE OF RHODE ISLAND.

X. ONCE APPROVED THE EXISTENCE OF THIS CORPORATION, A DRAFT OF THE INTERNAL REGULATION WILL BE WRITTEN THAT AFTER BEING SUBMITTED TO THE MOATSET HA'ZKENIM (COUNCIL OF ELDERS), WILL COME TO BE FUNCTIONAL AND APPLICABLE TO THE INSTITUTIONAL LIFE OF THE COMMUNITY.
