(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is The Greater Cranston Chamber of Commerce

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

TO PROMOTE THE GROWTH OF BUSINESS IN THE CITY OF CRANSTON, RI BY FORMING A MEMBERSHIP ORGANIZATION THAT WILL PROVIDE NETWORKING AND EDUCATIONAL SEMINARS TO THE BUSINESS COMMUNITY

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE CORPORATION WILL ADOPT BY-LAWS PROVIDING FOR THE ELECTION OF OFFICERS AND THE TENURE OF THEIR RESPECTIVE OFFICE; THE OBLIGATIONS AND CONDUCT OF MEMBERS FOR THE GENERAL CONDUCT OF THE BUSINESS OR CORPORATION. THE CORPORATION WILL ADOPT THE USE OF ROBERTS RULES OF ORDER AT MEETINGS.
