Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Envision Providence

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

SECTION 1. NON-PROFIT PURPOSE

THE CORPORATION IS A NON-PROFIT CORPORATION ORGANIZED AND OPERATED EXCLUSIVELY FOR RELIGIOUS PURPOSES AND IS NOT FORMED FOR PECUNIARY PROFIT OR FINANCIAL GAIN. THE PURPOSE OF THE CORPORATION IS TO ACT AND OPERATE AS AN ACCREDITED ORGANIZATION OF THE CHRISTIAN AND MISSIONARY ALLIANCE, A COLORADO NON-PROFIT CORPORATION. THE CORPORATION SHALL ACT

ONLY UNDER THE ECCLESIASTICAL AUTHORITY AND BE SUBJECT TO THE USAGES, DOCTRINES, AND TEACHINGS OF THE CHRISTIAN AND MISSIONARY ALLIANCE. THE CORPORATION WILL PROMULGATE SUCH DOCTRINES AND TEACHINGS, PREACH THE

GOSPEL TO EVERY CREATURE, EDIFY CHRISTIANS THROUGH THE EDUCATION OF GODS WORD, PROMOTE SPIRITUAL FELLOWSHIP AMONG GOD'S PEOPLE ON THE BASIS

OF BIBLICAL FAITH, PROMOTE RELIGIOUS ACTIVITIES, AND FURTHER OTHER RELIGIOUS, EDUCATIONAL, AND CHARITABLE WORK TO THOSE ENDS.

SECTION 2. SPECIFIC PURPOSE

THE SPECIFIC OBJECTIVES AND PURPOSES OF THIS CORPORATION SHALL BE TO WORK ALONGSIDE LOCAL CHURCHES AND MINISTRIES IN ORDER TO PROCLAIM THE

GOSPEL TO THE GREATER PROVIDENCE AREA.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

THE MEMBERSHIP OF THE CORPORATION SHALL CONSIST OF THE MEMBERS OF THE BOARD OF DIRECTORS.

THE NUMBER OF DIRECTORS, THEIR CLASSIFICATIONS, IF ANY, THEIR TERM IN OFFICE, AND THE MANNER OF THEIR ELECTION OR APPOINTMENT SHALL BE DETERMINED ACCORDING TO THE BYLAWS OF THE CORPORATION FROM TIME TO TIME IN FORCE.
