ORIGINAL ARTICLES OF INCORPORATION

The undersigned acting as incorporator (s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST. The name of the corporation is RRM, Inc.

(A close corporation pursuant to § 7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND. The period of its duration is (if perpetual, so state) Perpetual

THIRD. The purpose or purposes for which the corporation is organized are:

To conduct a business of builders and contractors, and to that end to deal in brick, stone, hardware, timber, and all other building materials; to enter into and carry out contracts for construction, alteration, repairing, furnishing, and improving of all kinds of buildings, as well as laying out and constructing all roads and outside structures that are necessary and pertinent to any and all of the above purposes; to negotiate for or perform all proper engineering and architectural undertakings; to advance money to builders and property owners; and to sell or lease any and all buildings so constructed and erected.

To enter into contracts with persons, firms and corporations for the construction of, excavation of, and to construct thereunder, buildings, public and private roads, highways, railroads, street railroads, bridges, abutments, walls, arches, viaducts, wharves, piers, sewers, cofferdams, and docks.

To construct a business of excavating, grading, landfill, and earth moving operations in general; of plowing snow, installing sewerage systems, underground tanks, water lines and other subsurface installations.

FOURTH. The aggregate number of shares which the corporation shall have authority to issue is:

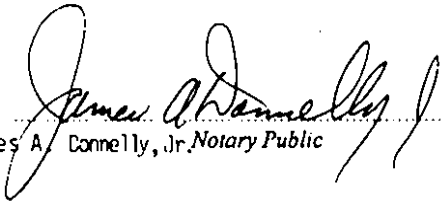
