Articles of Dissolution**

(Section 7-6-54 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is NorthPointe Christian Church

ARTICLE II

A resolution to dissolve the corporation was adopted in the following manner:

PRIORITY FOR DISTRIBUTION BE GIVEN TO THE OTHER POINTE CHRISTIAN CHURCHES IN RHODE ISLAND (WHICH NORTHPOINTE HELPED TO START), THEN THE REMAINING RESOURCES AS RESTORATION HOUSE MINISTRIES DEEMS APPROPRIATE FOR THE GOOD OF GOD'S

KINGDOM. ROBERT G. MILLER (PHONE: 731-589-1175), AS OUR CURRENT PASTOR AND EMPLOYEE OF RESTORATION HOUSE MINISTRIES WILL OVERSEE THIS DISTRIBUTION TO SEE THAT OUR WISHES OUR CARRIED OUT.

ARTICLE V

All of the remaining property and assets of the corporation have been transferred, conveyed or distributed in accordance with the provisions of Chapter 7-6.

ARTICLE VI

There are no suits pending against the corporation in any court in respect of which adequate provision has not been made for the satisfaction of any judgement, order or decree, which may be entered against it.
