ORIGINAL ARTICLES OF ORGANIZATION


Pursuant to the provisions of Chapter 7-16 of the Rhode Island General Laws, 1956, as amended, the following Articles of Organization are adopted for the limited liability company to be organized hereby:

- FIRST: The name of the limited liability company is **SAGG'S PROPERTIES, LLC** *cf. bill*
- SECOND: The name and address of the limited liability company's resident agent in Rhode Island is: Donald J. Packer, Esq., 1220 Kingstown Road, Peace Dale, RI 02879-2440
- THIRD: Under the terms of these Articles of Organization, and any written operating agreement made or intended to be made, the limited liability company is to be treated for purposes of federal income taxation as a partnership.
- FOURTH: The address of the principal office of the limited liability company has not yet been determined.
- FIFTH: The limited liability company is established for the purpose of engaging in any business which a limited partnership may carry on except the provision of professional services as defined in section 7-5.1-2, and shall have perpetual existence until dissolved or terminated in accordance with Chapter 7-16, unless more limited purpose or duration is set forth in paragraph SIXTH of these Articles of Organization.
- SIXTH: Additional provisions, if any, not inconsistent with law, which the members elect to have set forth in these Articles of Organization, including, but not limited to, any limitation of the purposes or duration for which the limited liability company is formed, and any other provision which may be included in an operating agreement: **NONE**
- SEVENTH: The limited liability company is to be managed by its members.
- EIGHTH: The limited liability company has no managers.
- NINTH: These Articles of Organization are to become effective upon their filing.


