(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

CODE OF 1986 (OR THE CORRESPONDING PROVISION OF ANY FUTURE UNITED
STATES INTERNAL
REVENUE LAW), AS THE BOARD OF DIRECTORS SHALL DETERMINE.

COURT OF THE

ARE ORGANIZED AND OPERATED EXCLUSIVELY FOR SUCH PURPOSES.
