FIRST. To associate ourselves together with the intention of forming a corporation under and by virtue of the powers conferred by Article-HI of Chapter 240 of the General Laws of Rhode Island.

SECOND. Said corporation shall be known by the name of B. V. G. & B. Employees Credit Union

THIRD. Said corporation is constituted for the purpose of forming a credit union with all the rights and powers appertaining thereto as authorized by Chapter 267 of the General Laws of Rhode Island or any other Statute of Rhode Island, and all acts in addition thereto or in emendment thereof. Provided, however, that membership in said credit union shall be restricted to regular employees of the Blackstone Valley Gas and Electric Company, a corporation having a usual place of business in Pawtucket in said State.

He addition to the foregoing, said corporation shall have the following powers and (See Sec. 75, Chapter 248 of the General Laws.)

To do any lawfur act which is necessary or proper to accomplish the purposes of its incorporation. Without limiting of enlarging the effect of this meneral grant of authority, it is hereby specifically provided that said corporation shall have power:

(b) to sue and be sued in its corporate name;

(c) to have and use a common scal, and alors the same at pleasure; (d) to elect such officers and appoint such agentine Its purposes require, and to fix their compensation and define their

⁽e) to make by-laws not inconsistent with the constitution or laws of the United States or of this state, or with those articles of association, determining the time and phase of bolding and the manner of calling and of conducting meetings of its members and directors, the manner of electing its officers and directors, the mode of volting by proxy, and the number, qualifications, powers, duties and term of office of its efficers and directors, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs;

FOURTH. Said corporation shall be located in Partucket. Rhode Island.
