all of lawful age, hereby agree to and with each other:
FIRST. To associate ourselves together with the intention of forming a corporation
under and by virtue of the powers conferred by Chapter 7-6 of the General Laws of
Rhode Island.
SECOND. Said corporation shall be known by the name of
Warwick Community Action, Inc.
THIRD. Said corporation is constituted for the purpose of planning, organizing,
supplementing, coordinating and executing a comprehensive community
action program to improve the economic and social life of the City of
Warwick, and to ald individuals and families in achieving their full

In addition to the foregoing, said corporation shall have the following powers and authority, viz:—(See §§ 7-6-7, 7-6-8 of the General Laws.)

economic and social potential, and to assist disadvantaged families and

persons of Warwick to make their full contribution to said program in an

effort to climinate the paradox of poverty in the midst of plenty, and

to do either directly or indirectly, alone or in conjunction with other

persons and organizations all acts and things incidental to the foregoing.

To do any lawful act which is necessary or proper to accomplish the purposes of its incorporation. Without limiting or enlarging the effect of this general grant of authority, it is hereby specifically provided that every such corporation shall have

⁽a) to have perpetual succession in its corporate name unless a period for its duration is limited in its articles of association or charter;

⁽b) to sue and he sued in its corporate name;

⁽c) to have and use a common seal and alter the same at pleasure;

⁽d) to elect such officers and appoint such agents as its purposes require, and to fix their compensation and define their duties:

⁽e) to make by-laws not inconsistent with the Constitution or laws of the United States or of this state, or with the corporation's charter or articles of association, determining the time and place of bolding and the manner of calling and of conducting meetings of its members and directors, the manner of electing its officers and directors, the mode of voting by proxy, and the number, qualifications, powers, duties and term of office of its officers and directors, and containing any other provisions, whether of the same or of a different nature, for the management of the corporation's property and the regulation and government of its affairs:

⁽f) to make contracts, incur liabilities and borrow money.

Said corporation shall be entitled to take, hold, transmit and convey real and personal estate to an amount not exceeding in all one hundred fifty thousand dollars (\$150,000); provided, however, that the foregoing limitation shall not apply to corporations organized for the purposes of fostering, encouraging and assisting the physical location, extdement or resettlement of industrial and manufacturing enterprises within the state, and to whose members no profit shall enture. If any corporation subject to the foregoing limitation desires to take and hold property to an amount exceeding one hundred fifty thousand dollars (\$150,000) either originally or by amendment, such privilege shall be granted only by the general assembly on petition thereto

FOURTH. Said corporation shall be located in Warwick., Rhode Island. (City of Town)
