Thank you for taking the time to notify this division when one of your client's corporations begin either receivership or bankruptcy proceedings. When we receive notification of the corporation's entrance into bankruptcy or receivership, the corporation's designation is changed to reflect its current status. It is not necessary for you to forward each motion or notice of payment which is issued as part of the proceedings. This division only retains for record the initial Bankruptcy or Receivership notice and court order of discharge or dissolution should it apply.

Our records indicate Bagels East, Inc. was issued a revocation certificate on November 14, 2001, for failure to file the 2001 annual report. The revocation certificate was issued after the corporation entered into receivership proceedings; therefore, please be advised that the Certificate of Revocation is void and has been canceled. There has been no lapse in the authority of the corporation to transact business in the State of Rhode Island due to the issuance of this Certificate of Revocation. Our records have been amended to reflect this cancellation.

However, enclosed you will find a 2001 and 2002 Annual Report to be completed and submitted for filing. Bagels East, Inc. has been restored to an active status but will not be considered in good standing until such time as the outstanding annual reports are filed.
