## ORDER

This matter came on for trial on the 23rd day of March, 1993 by agreement of the parties, it is hereby:

## ORDERED

- 1. This matter is settled pursuant to the following terms and conditions:
- l. Plaintiff shall be paid certain amounts as follows:
  - a. Defendant shall immediately turnover to the Plaintiff of all funds held in escrow in this matter, including all ownership interest in the funds held by or debentures issued by DEPCO or its successors or designees representing the funds originally placed in escrow in this action in 1990.

- b. In addition to (a) above Plaintiff shall also be paid by receiving payments from the Defendant as follows:
  - (i) On or before Friday, April 23, 1993 TWENTY FIVE THOUSAND (\$25,000.00) DOLLARS;
  - (ii) On or before Wednesday, July 7, 1993 FIFTEEN THOUSAND (\$15,000.00) DOLLARS and;
  - (iii) On or before Friday, September 10, 1993 TEN THOUSAND (\$10,000.00) DOLLARS.

All payments shall be made payable to the Plaintiff and delivered to OSTER & GROFF, 936 Smithfield Avenue, Lincoln, Rhode Island 02865 on or before the due date.

- 2. Defendants and James Armenakes shall hold the Plaintiff harmless and indemnify the Plaintiff against any and all claims of the Norwich Savings Society, Salvatore and Frances Cherezia and Katherine Evanuk relative to any notes or mortgages or claims they may have relative to interest in or claims arising out of ownership in the four Defendant corporations.
- 3. If the Defendants fail to make payments pursuant to paragraph one (1)b above Defendants and James Armenakes shall waive any and all objections they might have to Plaintiff's Petition For Receivership of the four Defendant corporations.
- 4. The Civil Action entitled James Armenakes v. James Caulfield, C.A. No. WC 90-416 shall be dismissed with prejudice, no costs upon the Plaintiff's executing a quitclaim deed of his interest in the real estate named in

that action and the Defendants in WC 8796, WC 89-797, WC 89-798 and WC 89-799 and James Armenakes shall hold the Plaintiff harmless and indemnify the Plaintiff against any and all claims of the Norwich Savings Society relative to this property and the notes and mortgages thereon.

Plaintiff in that action James Armenakes shall produce the deed for the Plaintiff in this action James Caulfield to sign.

- 5. Defendant corporations shall meet and ratify the actions contained in the agreement which compromises this Court Order.
- 6. Plaintiff shall not be liable for any claims against the corporations after December, 1990.
- 7. Plaintiff shall resign any and all offices and any and all interest he shall have in the Defendant corporations which resignation shall be accepted by the Defendants and effective December 1990.
- 8. Defendant corporations shall cease utilizing the name of the Plaintiff in any way related to the corporate filings with the Secretary of State.
