ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is AIM HIGH GYMNASTICS PARENTS ASSOCIATION (LC) 91521

SECOND: The period of its duration (if perpetual, so state) Perpetual

THIRD: The purpose or purposes for which the corporation is organized are: To support the association and coaching staff, to perpetuate and improve the sport of gymnastics, foster national and international amateur sports competition and develop amateur athletes for such competitions, to promote national and international gymnastics competition through sponsorship of meets, and the non-profit performance of activities permitted pursuant to IRS rules for 501(c)(3) corporations.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are: Upon dissolution of the corporation, the assets of the corporation shall be distributed exclusively to charitable, religious, scientific, testing for public safety, literary, or educational organizations which would then qualify under the provisions of Section 501 (c)(3) of the Internal Revenue Code and its Regulations as they exist or as they may hereafter be amended. 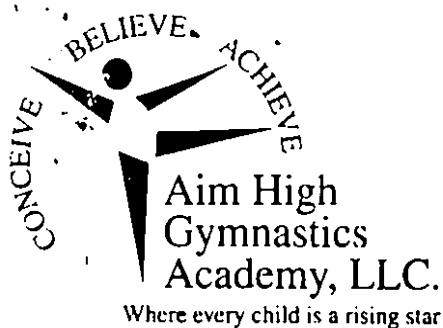
