ARTICLES OF INCORPORATION

The undersigned acting as incorporator (s) of a corporation under Chapter 7-1.1 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is NEW ENGLAND Live Audio, Inc.

(A close corporation pursuant to §7-1.1-51 of the General Laws, 1956, as amended) (strike if inapplicable)

SECOND: The period of its duration is (if perpetual, so state) perpetual

THIRD: The purpose or purposes for which the corporation is organized are:

Own and maintain mobile sound reinforcement equipment and theatrical lighting for the purpose of renting or leasing said equipment to individuals or businesses. Can be hired as consultants, or to set up, operate, breakdown, install, or repair such equipment. Can record events and duplicate recordings to be used at our discretion. Can subrent equipment of the same nature from other company's or individuals and operate such subrented equipment. The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary, profitable, or desirable for the furtherance of the corporate objectives expressed above.
