Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Compassionate and Loving Adult Day Care Center

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

COMPASSIONATE AND LOVING ADULT DAY CARE CENTER IS A NON-PROFIT CORPORATION AND SHALL OPERATE EXCLUSIVELY FOR EDUCATIONAL AND CHARITABLE PURPOSES WITHIN THE MEANING OF SECTION 501 (C)(3) OF THE INTERNAL REVENUE CODE, OR THE CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE. COMPASSIONATE AND LOVING ADULT DAY CARE PURPOSE IS TO

PROVIDE A LOVING, COMPASSIONATE, SAFE, HEALTHY AND EDUCATIONAL PLACE FOR THE ELDERLY AND DISABLED.

OUR MISSION IS TO BE ONE OF THE LEADING PRIMARY ADULT DAY HEALTH CARE CENTER FOR RHODE ISLAND'S ELDERLY AND DISABLED AND WE PLAN TO EXPAND SERVICES TO REACH ALTERNATE CULTURAL COMMUNITIES IN RHODE ISLAND. WE ACCOMPLISH THIS BY, HAVING KNOWLEDGEABLE, UNDERSTANDING AND CARING
