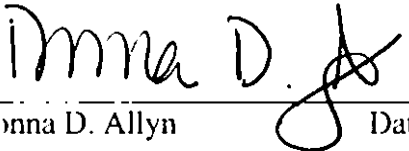
FURTHER RESOLVED, that the proceeds and remaining funds be promptly distributed to the member in accordance with their interest in the Company;

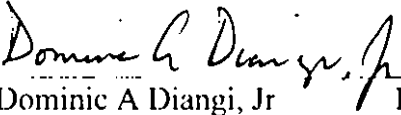
