THINGS THE LLC DETERMINES BENEFICIAL WITH REGARD TO REAL PROPERTIES; TO ENGAGE IN ANY ACTIVITIES DIRECTLY OR INDIRECTLY RELATED OR INCIDENTAL THERETO; TO ACT AS A BROKER AND ANY ANY OTHER LEGAL PURPOSE; TO ACT IN TO PURCHASE, OWN, DEVELOP, LEASE OR OTHERWISE HOLD SUCH PERSONAL PROPERTY AND EQUIPMENT AS MAY BE BENEFICIAL TO THE ACCOMPLISHMENT OF THE LLC'S PRIMARY PURPOSES DESCRIBED ABOVE; TO ENGAGE IN ANY AND ALL OTHER ACTIVITIES AS MAY BE NECESSARY, INCIDENTAL OR CONVENIENT TO CARRY OUT THE BUSINESS OF THE LLC; TO ESTABLISH, MAINTAIN AND OPERATE A FACILITY FOR SERVING THE ABOVE-DESCRIBED PURPOSES; TO ACQUIRE BY PURCHASE, LEASE, OR OTHERWISE AND TO IMPROVE AND DEVELOP REAL AND/OR PERSONAL PROPERTY WHEREVER THE LLC MAY DEEM APPROPRIATE; TO BUY, SELL, MORTGAGE, EXCHANGE, LEASE, LET, HOLD FOR INVESTMENT OR OTHERWISE, USE, AND OPERATE REAL ESTATE OF ALL KINDS, IMPROVED OR UNIMPROVED, AND ANY RIGHT OR INTEREST THEREIN. TO DO EVERYTHING NECESSARY AND PROPER FOR THE ACCOMPLISHMENT OF ANY OF THE PURPOSES OR THE ATTAINING OF ANY OF THE OBJECTS OR THE FURTHERANCE OF THE PURPOSES AND OBJECTS ENUMERATED IN THIS CERTIFICATE OF ORGANIZATION OR ANY AMENDMENT THEREOF, NECESSARY OR INCIDENTAL TO THE PROTECTION AND BENEFIT OF THE LLC, AND, IN GENERAL, EITHER ALONE OR IN THE ASSOCIATION WITH OTHER PROFESSIONALS, ASSOCIATIONS, CORPORATIONS, FIRMS, OR INDIVIDUALS, TO CARRY ON ANY LAWFUL PURSUIT NECESSARY OR INCIDENTAL TO THE ACCOMPLISHMENT OF THE PURPOSES OR ATTAINMENT OF THE OBJECTS OR THE FURTHERANCE OF SUCH PURPOSE OR PURPOSES OR OBJECTS OF THE LLC.
