Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Aurora Collaborative

ARTICLE II

The period of its duration is Perpetual

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE PURPOSES FOR WHICH THE AURORA COLLABORATIVE IS ORGANIZED ARE:

- A) TO PROVIDE A PROGRAM FOR STUDENTS, COMMUNITY MEMBERS, AND PROFESSIONAL ARTISTS AND MUSICIANS TO COLLABORATE ON PRODUCING CONCERTS IN THE COMMUNITY;
B) TO ESTABLISH A PLATFORM FOR ARTISTIC CREATORS OF ALL FORMS TO EXPLORE THEIR CREATIVE PASSIONS TOGETHER; AND
C) TO ORGANIZE CONCERT EVENTS IN THE COMMUNITY THAT FEATURE INTERGENERATIONAL AND MULTI-DISCIPLINARY COLLABORATION OF THE KINDS DESCRIBED ABOVE.

ARTICLE IV

Provisions, if any, not inconsistent with the law, which the incorporators elect to set forth in these articles of incorporation for the regulation of the internal affairs of the corporation are:

AURORA COLLABORATIVE IS ORGANIZED FOR CHARITABLE PURPOSES EXCLUSIVELY. ACCORDINGLY, THE CORPORATION SHALL NOT ENGAGE IN NON-TAX-EXEMPT ACTIVITIES, BEYOND RARE AND INSIGNIFICANT ACTIVITIES. THEREFORE, ALL SUBSTANTIVE ACTIVITIES CONDUCTED BY THE CORPORATION SHALL BE IN ACCORDANCE WITH THE PURPOSES SET FORTH BY SECTION 501(C) (3) OF THE INTERNAL REVENUE CODE.
UPON THE DISSOLUTION OF THE CORPORATION, ALL REMAINING ASSETS OF THE CORPORATION SHALL BE DISTRIBUTED BY THE BOARD OF DIRECTORS AMONG, EXCLUSIVELY, THE PAYMENT OF LIABILITIES OF THE CORPORATION AND THE DONATION TOWARD EXISTING NONPROFIT CORPORATIONS WHOSE STATUS IS IN ACCORDANCE WITH SECTION 501(C)(3) OF THE INTERNAL REVENUE CODE AND WHOSE ORGANIZATION IS MADE WITH THE PURPOSE OF PROMOTING COMMUNITY ARTISTIC PURSUITS AND OPPORTUNITIES IN RHODE ISLAND.
