Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

ARTICLE I

The name of the corporation is Rhode Island Career Development Assoc.

ARTICLE II

The period of its duration is Perpetual _____

ARTICLE III

The specific purpose or purposes for which the corporation is organized are:

THE RHODE ISLAND CAREER DEVELOPMENT ASSOCIATION PROVIDES A FORUM FOR THOSE WHO WISH TO IMPACT THE CAREER DEVELOPMENT OF ALL PEOPLE LIVING, WORKING, AND STUDYING IN THE STATE OF RHODE ISLAND. THROUGH ELECTRONIC

COMMUNICATION, NETWORKING, AND EDUCATIONAL EVENTS, THE ASSOCIATION FACILITATES THE SHARING OF TRADITIONAL BEST PRACTICES AND INNOVATIVE TECHNIQUES FOR CAREER DEVELOPMENT IN OUR EVER-CHANGING LOCAL AND GLOBAL JOB MARKETS.

THE SPECIFIC PURPOSES OF THE RHODE ISLAND CAREER DEVELOPMENT ASSOCIATION ARE TO:

1. LAY A FOUNDATION FOR THE EFFECTIVE DELIVERY OF CAREER DEVELOPMENT AND CAREER SELF-MANAGEMENT ACROSS THE LIFESPAN.
