Articles of Incorporation**

(Chapter 7-6-34 of the General Laws of Rhode Island, 1956, as amended)

**ARTICLE I**

The name of the corporation is Jr. Mounties, Inc.

**ARTICLE II**

**ARTICLE III**

The specific purpose or purposes for which the corporation is organized are:

TO THE EXTENT AUTHORIZED BY CHAPTER 7-6 OF THE GENERAL LAWS TO CONDUCT AND CARRY ON THE ACTIVITIES OF THE CLUB NOT FOR PROFIT. NO PART OF ITS INCOME OR PROPERTY SHALL INURE TO THE PRIVATE BENEFIT OF ANY MEMBER, TRUSTEE OR OFFICER. THESE ACTIVITIES MAY INCLUDE ORGANIZING AND PROMOTING YOUTH HOCKEY, ENCOURAGING PROPER ENGAGEMENT IN ATHLETIC EXERCISES, AND ENGAGING IN ALL ACTIVITIES ALLOWED BY LAW TO A RHODE ISLAND NON-PROFIT CORPORATION.

SAID ORGANIZATION IS ORGANIZED EXCLUSIVELY FOR CHARITABLE, RELIGIOUS, EDUCATIONAL, AND SCIENTIFIC PURPOSES, INCLUDING, FOR SUCH PURPOSES, THE MAKING OF DISTRIBUTIONS TO ORGANIZATIONS QUALIFYING AS AN EXEMPT ORGANIZATION FROM FEDERAL INCOME TAX UNDER SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE, OR CORRESPONDING SECTION OF ANY FUTURE FEDERAL TAX CODE.

IN THE EVENT OF TERMINATION, DISSOLUTION, OR WINDING UP OF THE CORPORATION IN ANY MANNER OR FOR ANY REASON WHATSOEVER, ITS REMAINING ASSETS, IF ANY SHALL BE DISTRIBUTED TO ONE OR MORE ORGANIZATIONS DESCRIBED IN SECTION 501 (C) (3) OF THE INTERNAL REVENUE CODE
