

Re: Reservation of Name.

Dear Secretary of State;

I am Pastor Abraham Fashakin the President and Incorporator of the above named religious non-profit organization (Church) Providence, Rhode Island.

My main purpose of writing this letter to you is to call your attention to letter dated December 10, 1986 in which we wrote that we would like to reserve the name of our church THE UNIVERSAL CHERUBIM AND SERAPHIM CHURCH MOVEMENT AMERICA INC. PROVIDENCE RHODE ISLAND, for our exclusive use as permitted by Law and as quoted above. A copy of the said letter is attached.

To our surprise and shock, a breakaway group from our church in Providence, Rhode Island categorically confirmed to us that they had registered their own church as LOVE DIVINE CHERUBIM AND SERAPHIM MOVEMENT; while our own name is THE UNIVERSAL CHERUBIM AND SERAPHIM CHURCH MOVEMENT. There are too many similarities in the two groups as you can see yourself. If their claim is true, that they had registered their church with the State Department, this could be very confusing, embarrassing, misleading and very disappointing.

They are currently using 83-85 Carr Street as their place of worship, and our former registered Agent Fred Adesuyi of 55 Harriet St. Providence, RI is now their current leader. We painfully regard their action as nothing but FRAUD.

Could you please look into this matter and make all necessary restitutions before things get out-of-hand. Please let us read from you soon as to what actions you have taken to stop them from using a name that is very much similar to ours.

RE: Termination as Church Representative or
Agent of C & S Church of America

Dear Sir:

I, Pastor Abraham Fashakim, the President and Founder of the Universal Cherubim and Seraphim Church of America including the Board members voted unanimously to permanently terminate you as the representative-in-charge of our Providence, RI branch of the Universal Cherubim and Seraphim Church of America during the Board meeting of May 1, 1990.

The above decision was unanimously reached by the Board members for the following reasons:

(a) you have intentionally turned the Church into a profit entity which is contrary to what the Church stands for,

(b) you have intentionally plotted to remove the Pastor/Founder's signature from the signatories of Church account,

(c) you have intentionally refused to follow the guidelines and policies of the Church,

(d) you have intentionally misrepresented the instructions of the Pastor/Founder to the congregation,

(e) you have encouraged the members to be disloyal to the Pastor/Founder of the Church,

(f) you have mismanaged the Church funds,

(g) you have encouraged and practiced fraud in the Church,

(h) you have encouraged buying and selling in the House of God.

(i) you have continuously taken the Church fund without formal authorization from the headquarters.

For the past few years, I, the Founder and President of this organization have been monitoring the progress of all of the affiliations or branches of the Universal Cherubim and Seraphim Church of America. The Providence, RI branch has fallen from grace under your supervision as the representative or agent. The conditions of the Church have continuously deteriorated. You have encouraged backstabbing, coveteousness, arrogancy, conducting personal business in the Church, fraud, intent to dispose the Founder and Pastor of the Church, formed your own committees without the approval of the headquarters in New York. All of the above, among other things have contributed to your downfall. I have warned you of all these problems time and time again for the past several years but you have refused to yield to my warnings, neither have you listened to the warnings of GOD.

The conduct described herein above have caused significant drawbacks for the progress of the Church, many sheep. i.e. Church members, who are in spirit to worship GOD have been lost, you have chosen to gather your own sheep without my authorizations as the President and Founder of the Church, and you have diverted the Church funds for your own personal uses. You have even decided to print some new checkbooks for the Church without my permission. Mismanagement of funds is very rampant. The last deposit you made at the bank was in October, 1989.

You may recall in 1988, Mr. Akinnusotu, the Treasurer, you and I, audited the Church account in which you were in charge. The result was a discrepancy of NINE HUNDRED DOLLARS (\$900.00). The financial record of the Church showed a \$900.00 deficit which you could not account for as representative of the Church. I trusted you so much and I put you in charge of the Rhode Island branch to oversee the running of the Church during my absence, but you failed. As I recall, this \$900.00 deficit was recorded against you by our Treasurer, Mr. Richard Akinnusotu.

Early in 1989, as part of the efforts I was making to put the Church back on the right track, I instructed Sister Victoria Adeniyi to audit the Church account. She also discovered several

financial discrepancies. After much questioning, you could not account for still more missing funds or justify any expenses you claimed the Church incurred. Again, this is another fraudulent act in your part as a representative of the Church.

Consequently, after these two incidents in May, 1989, another effort was made to audit the Church record but you refused to cooperate, you continue to avoid my instructions and barred me from auditing this account. Eventually, after several months of waiting, in February, 1990, you told me over the phone that one Mr. Joshua Odugbela told you the Church account could not be audited. My questions to you, Mr. Adesuyi are: Who founded this Church? Who placed you as leader-in-charge of the Providence, RI branch? Who do you report to? I believe the founder and Founder and President is the only person you are supposed to report to. FRAUD! FRAUD! FRAUD has become the order of the day in the name of the Lord? When will this stop? I believe you have committed a dubious crime against the Holy Spirit!

Taking a closer look at your performance in the Church since 1986, you organized a committee of your own with intent to commit fraud, organized a committee of your own with intent to disrupt the work of our Lord Jesus Christ. Most of all, you have decided not to stay with GOD. You have decided not to gather with GOD. You have decided to commit blasphemy against the Holy Spirit and moreover, you have spoken against the Holy Spirit.

In view of the above circumstances, and for the simple reason that I have to protect the interest of the Church, I have no other choice but to TERMINATE you from the post of Church Representative effective from the date of this letter. you no longer represent this church (the Universal Cherubim and Seraphim Church of America, Inc.) Providence, RI, You shall be held accountable for whatever fraud, mismanagement of funds or other illegal activities that have taken place in the Church from December, 1986 to the date of this letter. However, this decision does not constitute the dissolution of the Church, the Church remains, but you, Mr. Fredrick Adesuyi is no longer the legal representative or agent of this Church.

Please be advised that the State Employee Credit Union (the Church Bank) has been notified that you are no longer the representative or agent of this Church in Providence, RI and as such, your name has been removed as one of the signatories of the Church account. The bank has been notified by the Church's lawyer. We have also notified the State Department in Providence of this decision.

You are further advised that you are to turn in the HOLY ROD,

THE CHURCH BELL and all properties of the Church no later than one week of the date of this letter of termination. It is rather unfortunate that, I, as a leader, proprietor, founder and President of the Church have to make this type of decision, however, it is in the best interest of the work of God and the Universal Cherubim and Seraphim Church of America, Inc. Please feel free to contact me at the above address or call the phone indicated above should any additional information be required.
