ORIGINAL ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a corporation under Chapter 7-6 of the General Laws, 1956, as amended, adopt(s) the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is West Kingston Fire Department, Inc.

SECOND: The period of its duration (if perpetual, so state) Perpetual

THIRD: The purpose or purposes for which the corporation is organized are:

organizing, training and maintaining a volunteer fire department, together with water and ice rescue facilities, in the West Kingston-Usquepaugh area, of the Town of South Kingstown, Rhode Island, or in such other areas of the Town of South Kingstown, Rhode Island as may be prescribed by the Board of Wardens of the Union Fire District of the Town of South Kingstown.

FOURTH: Provisions (if any) for the regulation of the internal affairs of the corporation, including provisions for the distribution of assets on dissolution or final liquidation, are: (Note 1)

The By-Laws and Charter of this corporation shall not be in conflict with the Charter, By-Laws, rules and regulations of the Union Fire District of the Town of South Kingstown.

By the organization of this corporation, the said corporation recognizes that its fire fighting and rescue activities come under the jurisdiction of the Union Fire District of the Town of South Kingstown, and membership, and the qualification for membership in said Fire Company shall be determined by the Company's adopted By-Laws, provided they do not conflict with the Charter, By-Laws, rules and regulations of the Union Fire District of the Town of South Kingstown.
